

Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) and American Rescue Plan Act (ARP)

On December 27, 2020, and subsequently on March 11, 2021, two additional relief acts were signed into law: the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), and the American Rescue Plan Act (ARP) of 2021. As part of CRRSAA and ARP, universities and colleges across the country were allocated funding through the Higher Education Emergency Relief Fund (HEERF). Purdue University Global has received and awarded its students monies through HEERF. The fund may cover any component of the student's cost of attendance at Purdue Global or to offset emergency costs that have arisen due to the coronavirus pandemic, such as costs for food, housing, health care (including mental health care) or child care. If a student is deemed eligible, the student has received or will receive a notification from the university. 1. **An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 314(a)(1) of CRRSAA and Section 2003(a)(1) of ARP to provide Emergency Financial Aid Grants to students.** Purdue University Global signed and returned the Certification and Agreement to the Department of Education on April 13, 2021.
2. **The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.** \$38,611,191 (CRRSAA - \$14,047,709, ARP - \$24,563,482)
3. **The total amount of Emergency Financial Aid Grants distributed to students under Section 314(a)(1) of CRRSAA and Section 2003(a)(1) of ARP as of the date of submission (i.e., as of the 30-day Report and this information must also be updated no later than 10 days after the end of each calendar quarter (September 30, December 31, March 31, and June 30)).** In August 2021, PG distributed the grants in the amount of \$8,895,000. Of \$8,895,000, \$3,932,709 was allocated from HEERF II and \$4,962,291 was issued from HEERF III. The University has been notified of the unclaimed checks from students. The remainder of the unused funds was redistributed to other students during the 2nd quarter of 2022. The revised amount for the 3rd quarter of 2021 is \$8,830,000.
4. **The estimated total number of students at the institution eligible to participate in HEERF funding programs under Section 314(a)(1) of CRRSAA and Section 2003(a)(1) of ARP.** 20,875 - unduplicated count of eligible students at the time of awarding in August 2021.
5. **The total number of students who have received an Emergency Financial Aid Grant to students under Section 314(a)(1) of CRRSAA and Section 2003(a)(1) of ARP.**
 - 8,895 at the time of awarding in August 2021.
 - 8,830 as of June 30, 2022

6. **The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 314(a)(1) of CRRSAA and Section 2003(a)(1) of ARP.** Purdue University Global has determined the grant eligibility based on the Expected Family Contribution (EFC) represented within their FAFSA. The University prioritized grant recipients by examining the individual needs with the lowest EFC. Students who received the grant in April 2021 were excluded from the August 2021 distribution.
7. **Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.** The University sent an email to the students who received the grant on September 1, 2021 (see a copy of the email below).
