Associate of Applied Science in Legal Support and Services

The Associate of Applied Science in Legal Support and Services program is designed to offer you a comprehensive study in areas such as legal research and writing, civil litigation, legal ethics, torts, and various legal disciplines to prepare you for diverse opportunities in the legal field. You will gain foundational knowledge of the law and legal administrative skills.

The program prepares you to provide legal services and support not only in law firms but also in corporations, health care institutions, and more. Graduates can pursue career paths in environments that include contract-driven industries such as real estate and licensing, corporate legal departments, the court and judicial system, legal firms, insurance companies, and consulting firms.

Bachelor of Science in Legal Support and Services

The Bachelor of Science in Legal Support and Services degree program provides a solid foundation in legal theory and practice, offering you broad-based knowledge of the law as well as practical areas of study required by many professions both inside and outside the legal field. The program could also prepare you for or enhance your skills within the paralegal field.

The legal education and training provided in the Bachelor of Science in Legal Support and Services program may prove useful if you are interested in pursuing occupations in the legal, business, government, health care, banking, real estate, or service industry, including the following: title examiner, paralegal, legal assistant, and legal secretary.

Our program offers a practical curriculum and specialized elective options that allow you to customize your education, including a concentration in paralegal studies. The paralegal concentration includes courses in litigation, criminal law, and administrative law.

Master of Science in Legal Studies

The Master of Science in Legal Studies program is designed to provide a solid foundation in legal doctrine and concepts while developing and refining your ability to identify and analyze legal issues. If you are not interested in practicing law, but want to develop a better understanding of the law as it affects your career or other areas of interest, this may be the program for you. The program in legal studies does not prepare you for the practice of law, and you are not eligible to sit for any state's bar examination based solely on your completion of this program.

Upon graduation, you could pursue career opportunities in law and law-related fields, which you can find in government, nonprofit, or business organizations,² or you may prepare for further graduate study to advance your career goals.⁶

Admissions

Admissions Overview

Basic Requirements

Undergraduate Applicants

You must have completed high school or received a General Equivalency Diploma (GED) or other approved equivalent.

Graduate Applicants

You must have completed a bachelor's degree program at an accredited college or university with a 2.5 cumulative grade point average (CGPA) or higher.

International Applicants

You will need to provide evidence of English language proficiency.

Transcripts from foreign institutions must meet the same requirements as domestic institutions and must be translated and evaluated by an approved foreign credential evaluator prior to enrollment.

Speak to your Admissions Advisor for information related to international availability. Not all programs are available for enrollment.
