1. 5. Nothing herein shall constitute any obligation on Kaplan and PG to make any use of the rights herein granted. I acknowledge that Kaplan and PG have the right but not the obligation to use, display or include My Appearance and that Kaplan and PG may cease the display, streaming or broadcast of My Appearance (or any portion thereof), at any time for any reason whatsoever.

This Media Release contains the entire understanding between the parties regarding the subject matter hereof, supersedes all prior understandings and may not be modified except in a writing signed by both parties hereto. Any waiver of a breach of any portion of this Media Release shall not be construed as a continuing waiver with regard to a subsequent breach. This license shall be construed in accordance with the laws of the State of Florida.
