Tuition Cap

TUITION

The tuition rates are \$371.00 per quarter credit hour for undergraduate/certificate programs (\$315.00 per quarter credit hour for the Associate of Science in Nursing and RN-to-BSN programs).

The tuition rates are \$485.00 per quarter credit hour for Master of Health Care Administration and graduate business degree/certificate programs and \$420.00 for all other graduate degree/certificate programs. Tuition per quarter credit hour for the Doctor of Nursing Practice program is \$700.00.

ExcelTrack™: Tuition for Purdue Global ExcelTrack programs is \$2,200 per term (undergraduate programs), \$3,200 per term (for MSN ExcelTrack courses; \$320/module if fewer than 10 modules are taken in combination with a traditional course; tuition for traditional courses is \$420.00 per quarter credit hour), or \$1,550 per term (MBA). These programs are not VA/TA approved. Military servicemembers, veterans, and spouses are not eligible for military tuition reductions on ExcelTrack programs.

Undergraduate Tuition for Military Personnel

- For U.S. military servicemembers, tuition for Purdue Global undergraduate degree and certificate programs is \$165.00 per quarter credit hour. U.S. military servicemembers include active duty and members of the Guard or Reserve on drill status.
- For U.S. military veteran servicemembers, tuition for Purdue Global undergraduate degree and certificate programs is \$230.00 per quarter credit hour.
- Military spouses, including spouses of servicemembers and veterans, are eligible for a 10% tuition reduction on undergraduate degree and certificate programs.
- Military reductions may not be combined with any other Purdue Global discount, scholarship, or tuition voucher.

Graduate Tuition for Military Personnel

- For U.S. military servicemembers, tuition for Purdue Global graduate programs is \$320.00 per quarter credit hour. U.S. military servicemembers include active duty and members of the Guard or Reserve on drill status.
- U.S. military veteran servicemembers are eligible for a 14% tuition reduction.
- Military spouses, including spouses of servicemembers and veterans, are eligible for a 10% tuition reduction on graduate programs.
- Military reductions may not be combined with any other Purdue Global discount, scholarship, or tuition voucher.

Active-duty servicemembers are eligible for a 20% tuition reduction on doctorate program tuition, veterans are eligible for a 15% reduction on doctorate program tuition, and spouses of active-duty servicemembers are eligible for a 10% reduction on doctorate program tuition.

Total cost of tuition is based on the recommended sequence of classes and credits per term with no deviations from that recommended sequence, and at the current rate of tuition. This amount is also based on program requirements, and can change if a student decides to pursue a different program. Student can be subject to additional charges for repeating failed classes.

Purdue Global Tuition Cap

Tuition Cap Tuition for Purdue Global undergraduate online programs is \$371.00 per quarter credit hour. The Purdue Global Tuition Cap is only available to first-time Purdue Global enrollees in predetermined programs, with a total cost of completion of \$22,500.00 (associate's degrees) or \$45,000.00 (bachelor's degrees). With the exception of background check and/or lab fees, tuition and fees are included in the calculation of the overall Tuition Cap program cost and will no longer be charged once the student has reached the total cost of completion.

FEES

Unless otherwise noted, these fees are payable directly to Purdue Global, may be paid using financial aid funds, and can be incorporated into the student's monthly payment plan.

Application

A nonrefundable application fee of \$45.00 is due at the time the enrollment agreement is signed. Application fees are not charged to U.S. military servicemembers. (Application fee waived for campus and learning center students through December 31, 2018.)

Instructional Materials

Associate of Science in Nursing: In addition to the tuition cost, students must purchase textbooks, supplies and other instructional material (the "Instructional Material") each term as may be required for the Associate of Science in Nursing program course work for such term. The Instructional Material can be purchased from the campus bookstore or through other sources. The cost per term for the Instructional Material varies based on the Instructional Material required for each individual term. The estimated cost of instructional Material per program for a full-time student is approximately \$2,300.00 (\$2,225.00 for textbooks and \$75.00 for other supplies—scrubs, watch, bandages, hemostat, stethoscope, etc.). Books and instructional materials are provided at no cost to U.S. military servicemembers.

Prelicensure Bachelor of Science Nursing: Students enrolled in the Prelicensure Bachelor of Science in Nursing program option will pay a fee of \$150.00 per course containing a clinical component and \$75.00 per course containing a laboratory component. These fees may be paid using financial aid funds and can be incorporated into the student's monthly payment plan.

In addition to the tuition cost, students must purchase textbooks, supplies and other instructional material (the "Instructional Material") each term as may be required for the Prelicensure Bachelor of Science in Nursing program coursework for such term. The Instructional Material can be purchased from the campus bookstore or through other sources. The cost per term for the Instructional Material varies based on the Instructional Material required for each individual term.

The estimated cost of Instructional Material for the Prelicensure Bachelor of Science in Nursing program for a full-time student is approximately \$2,650.00 (\$2,500.00 for textbooks and \$150.00 for other supplies—scrubs, watch, bandages, hemostat, stethoscope, etc.). Books and instructional materials are provided at no cost to U.S. military servicemembers.

Undergraduate Programs: Books and instructional materials are estimated at \$50 to \$250 per course. Books and instructional materials are provided at no cost to U.S. military servicemembers enrolled in all undergraduate programs. This fee is waived for other undergraduate students enrolled in academic programs other than the Practical Nursing Diploma, the Associate of Science in Nursing, or the Prelicensure Bachelor of Science in Nursing. Not all courses require textbooks; some use electronic instructional materials. Some courses may require students to purchase additional course materials from another source. Students may purchase supplemental course materials at a retail price predetermined by campus administration. Please see the campus bookstore for details regarding book and course material distribution and purchasing policies.

Graduate Programs: Books and instructional materials are estimated at \$50 to \$250 per course. Students must purchase the textbooks and supplies required for coursework each term. Textbooks and supplies may be purchased through the college bookstore or through other sources. This is the approximate cost of books and supplies per term for a full-time student.

Course Fee

The following course has additional fees (quarter credit programs). There is no refund of course fees once the student has attended the course.

Technology

Students are required to pay a \$295.00 technology fee per term (\$200.00 for graduate-level U.S. military servicemembers and all veterans and military spouses; technology fees are not charged to U.S. military servicemembers enrolled in undergraduate programs). For the graduate business, information technology, and education programs, MSCJ, and MSHSEM, this fee is prorated to \$150.00 per six-week term (\$100.00 for U.S. military servicemembers, veterans, and military spouses).

Additional Technology Requirements for Courses

Along with the Technology Requirements listed in the Catalog, all students should review and be aware of any additional software and hardware requirements for their classes prior to enrollment. EL 206

Students enrolled in EL 206 will pay a \$1,500.00 course fee. This nonrefundable fee will be collected as follows: 50% after add/drop week and 50% upon submission of a portfolio for evaluation. Students who withdraw from the course after add/drop week, withdraw from Purdue Global before completing the course, fail the course, or do not submit a portfolio after completion of the course will not be charged the remaining \$750.00. This fee may be paid using financial aid funds and can be incorporated into the student's monthly payment plan.

Open College Course LRC 100

Students enrolled in the Open College@Purdue Global course LRC 100 will pay a \$1,500 assessment fee when they submit their portfolio for evaluation. This nonrefundable fee may be covered by financial aid.

Course Assessments

A fee of \$100.00 is required for each course assessment taken.

Transcripts

A fee of \$10.00 is charged for each copy of an official transcript. A \$2.00 shipping and handling fee will be charged if the receiving school is unable to accept electronic delivery. Additional fees are as follows: notarized, \$30.00; rush delivery, \$25.00. Students will receive one free copy of their official diploma. Additional fees are as follows: duplicate/replacement, \$25.00 (free if damaged in shipment or printed with errors); notarized, \$30.00; apostille, \$100.00.

Returned Checks

A \$25.00 fee will be added for all returned checks.

POLICIES

1. Tuition and fees are subject to change after 30 days' advance notice. See the current University Catalog/Addendum for an explanation of the Refund Policy. Students may make tuition payments via the following website: <https://paymentcenter.purdueglobal.com/>.
2. Military spouses are eligible for a 10% tuition reduction on undergraduate and graduate programs. Purdue Global is a participant in the Yellow Ribbon provision for eligible servicemembers. Spouses and dependents of eligible servicemembers who receive a transfer of benefits under the Post-9/11 GI Bill chapter 33 may be entitled to the Yellow Ribbon provision. These reductions may not be used in conjunction with scholarships or other reductions.
3. Not all programs are available at all locations. Check with an Admissions Advisor.
4. Tuition Cap: Enrollees in Tuition Cap programs will pay an additional \$200.00 per-term Administration Fee (which also counts toward the Tuition Cap).
5. Failure to return library materials to Purdue Global or any of its partner libraries will result in a financial obligation to Purdue Global and may result in postponement of registration for a new term or graduation. Instructional materials must be returned unused within 14 days from the date the student notifies the University of cancellation of enrollment. The student will be responsible for payment of any bill received for instructional materials not returned.
6. Upon enrollment, students must attest to high school graduation or equivalent. The University may require students to present actual proof of graduation or its equivalent as part of its verification process.
7. Postbaccalaureate program enrollees: Students must furnish an official transcript indicating receipt of a comparable associate's degree or bachelor's degree (selected programs) or bachelor's degree (postbaccalaureate programs) from a college or university accredited by a regional or national accrediting agency recognized by the U.S. Department of Education by the last day of the first term. If this document is not submitted by the last day of the first term, the student will be withdrawn from the University and blocked from reentry until it is provided or the student changes his or her program of study to one that does not require proof of graduation. Furthermore, all Title IV financial aid or any state or institutional funding must be refunded to the appropriate source, and the student will be responsible for payment of these funds to the original source or to Purdue Global.
8. Cancellation of Enrollment Agreement: Three-Day Cancellation—An applicant who provides written notice of cancellation within three days (excluding Saturday, Sunday, and federal and state holidays) of signing an Enrollment Agreement is entitled to a refund of all monies paid.

Program Fees: Students enrolled in the **Master of Science in Higher Education/Student Affairs** must have an approved criminal background check from the Purdue Global approved vendor on file prior to the first day of the first term. The fee is \$41.00 and is the responsibility of the student where applicable. **Master of Arts in Teaching (Iowa Certification and Noncertification Tracks)** students will pay a one-time fee of \$155.00 for LiveText software. **Master of Arts in Teaching–Iowa Certification Track** candidates must have an approved criminal background check from the Purdue Global approved vendor on file prior to the first day of the first term. The fee is \$75.00, is the responsibility of the student, where applicable, and is required to be paid directly to the provider. Prior to enrollment, Master of Arts in Teaching–Iowa Certification Track candidates are required to obtain a transcript analysis showing that the minimum content hours in the teaching endorsement area have been met. Master of Arts in Teaching–Iowa Certification Track graduates who are recommended for full licensure will be required to pay the Iowa BoEE a licensing fee application of approximately \$85.00. **MAT–Noncertification Track** students who choose the Classroom Pathways Bundle with the American Board for Certification of Teacher Excellence Plus+ Program will pay a one-time fee of \$2,850.00 (\$3,000.00 for Arizona residents; \$1,425.00 in each of the last two terms of the MAT program; \$1,500.00 in each of the last two terms for Arizona residents). Program Fees: Students enrolled in the **Master of Public Health** and **Master of Science in Health Education** are required to pay a one-time program fee of \$300.00 during initial program enrollment. Students who leave the University and reenroll in the same program at a later date are not reassessed the fee. Students enrolled in some undergraduate health sciences programs are required to pay a one-time program fee during initial program enrollment. The fee per program is as follows: **Bachelor of Science in Health Information Management**, \$300.00; **online Medical Assistant Certificate**, \$1,050.00 (payable in three installments of \$350.00 each in the first three terms); **Medical Billing and Coding Certificate**, \$175.00; **Medical Office Administration Certificate**, \$300.00. This fee is not charged if a student re-enrolls into the same program. These fees may be paid using financial aid funds and can be incorporated into the student's monthly payment plan. The program fees are nonrefundable and payable over the term in which the fee is billed. Students enrolled in a **School of Health Sciences program that requires criminal background checks** will be required to submit a request for a criminal background check to the Purdue Global approved vendor: (1) prior to the first day of the first term (the fee is \$44.00 and is the responsibility of the student to pay the vendor directly where applicable); (2) during clinical orientation if the initial background check will be more than 1 year old by the date the clinical is completed or if requested by the clinical site (the fee is \$29.00 and is the responsibility of the student where applicable).
