

EXPERIENTIAL LEARNING CREDIT GRANT TERMS AND CONDITIONS

AWARD DESCRIPTION

The Purdue University Global Experiential Learning Credit Grant is a one-time tuition reduction of up to \$1,500.00 available to Purdue Global enrollees who complete a Purdue Global experiential learning course (EL 206 or LRC 100), submit a portfolio for review, but are not recommended for the equivalent of up to \$1,500.00 in college credit toward a Purdue Global undergraduate degree. The amount of the Grant will be the difference between \$1,500.00 and the value of the college credit(s) actually recommended.

GENERAL ELIGIBILITY CRITERIA TO QUALIFY FOR THE EXPERIENTIAL LEARNING CREDIT GRANT

EL 206 Enrollee:

- Must be enrolled in an eligible Purdue Global undergraduate program.
- Must pass EL 206 as an open elective course within an undergraduate degree program at Purdue Global.
- Must submit an experiential learning portfolio for review, including building a minimum of two course petitions.
- Must have paid the \$1,500.00 portfolio assessment fee.
- Must remain enrolled and active in the next available Purdue Global term.

Students registered in EL 206 are allowed to take a single six-credit hour course in the term immediately following EL 206.

LRC 100 Enrollee:

- Must pass all quizzes within LRC 100 and submit work for feedback within all LRC 100 modules.
- Must submit an experiential learning portfolio for review, including building a minimum of two course petitions.
- Must have paid the \$1,500.00 portfolio assessment fee.
- Must enroll in a Purdue Global undergraduate program within 60 days of submitting an experiential learning portfolio. If eligible, the Grant would be awarded in the second term of study (the learning portfolio will be reviewed and assessed for credit during the first term of enrollment at Purdue Global).

Exclusions:

The Experiential Learning Credit Grant is not available to recipients who did not pay the \$1,500.00 portfolio assessment fee or are recipients of other Purdue Global experiential learning course fee reductions.

OTHER TERMS AND CONDITIONS

- Must meet all Purdue Global admissions requirements for the undergraduate degree program, including GED or high school equivalent, and be fully accepted into one of the Purdue Global eligible online undergraduate degree programs.
- If the student meets all eligibility criteria to qualify, the Grant will be applied after add/drop week of the next available term as a tuition credit of up to \$1,500.00. The Grant has no cash value.
- The Grant may be used in conjunction with other Purdue Global tuition reductions (including active-duty and veterans military tuition rates), grants, vouchers, or other scholarships.

CONTINUED ELIGIBILITY

- Award recipient must remain in good financial standing with Purdue Global.
- Award recipient must be continuously enrolled at Purdue Global. With the exception of an approved leave of absence, students who withdraw will no longer be eligible for the Grant.
- Purdue Global reserves the right to amend grant policies or awards, or discontinue awarding grants to additional students at any time.
